- The "Accidental" Franchise
- Disclosure and/or Registration Violations
- Misrepresentation and Unauthorized FPRs
- Violation of State Relationship Statutes
- Unfair or Deceptive Trade Practices
- Breach of the Implied Covenant of Good Faith and Fair Dealing
- Encroachment of Exclusive Territories



## Frequent Franchisee Claims and Franchisor Defenses

- Wrongful Termination of Franchise Agreement
- Refusal to Renew Franchise Agreement
- Denial of Right to Transfer or Assign Franchise Agreement
- Failure to Provide Training and Support
- Marketing Fund Mismanagement
- Antitrust and Tying Restraints



### Frequent Franchisor Claims and Franchisee Defenses

- Noncompliance with System Standards
- Failure to Pay Royalties and Other Contractual Payments
- Holdover Franchisees / Trademark Infringement
- Improper Use / Disclosure of Confidential Trade Secrets
- Violation of In-Term Noncompetes
- Violation of Post-Term Noncompetes

- Rescission and Restitution
- Injunctive Relief
- Specific Performance
- Declaratory Judgments
- Punitive Damages


